




PITTSBURGH REGIONAL 1st Quarter 2017 M&A TRANSACTIONS



➤ Quarterly regional M&A volume increased from 26 transactions in July of 2016 to 29 transactions in March of 2017. A total of 86 transactions were completed in the first quarter of 2017, compared to 75 in the third quarter and 92 in the fourth quarter of 2016.



➤ Strategic buyers completed 91.9% of the total transactions in the first quarter of 2017. Strategic buyers have a large amount of cash on their balance sheets and continue to buy into markets. Financial buyers not only face stiff competition from aggressive strategic buyers, but also a dearth of quality platforms.



➤ In the first quarter of 2017, regional M&A targets were primarily concentrated in the Industrials (28%), Materials (16%), Consumer Discretionary (15%), Financials (15%), and Information Technology (9%) sectors.
